TREAT

Deciding what you wish to give

We recognize that your first priority when making a Will is to provide for your loved ones. However, many people find that even after they have done this they can still leave a gift in their Will to charity. Leaving a gift in your Will to SPANA is one of the most valuable and lasting ways you can support working animals.

ONE A good way to help is to leave a percentage or share of what is left of your estate (known as a residuary bequest) after you have provided for your loved ones and all financial commitments have been paid. This way, as the value of your assets increase or decrease, your legacy will adjust also.

TWO You may wish to leave a fixed sum of money (known as a pecuniary bequest). Please bear in mind that this type of gift does not allow for changes in your circumstances or inflation.

THREE You can leave a particular item (known as a specific bequest), such as a piece of art or jewellery, which can be sold to support our work.

Sample wording to leave a bequest to SPANA. The following wording may assist your solicitor.

If you wish to donate a percentage of your estate after providing for loved ones:

"I give XX% of my estate to The Society for the Protection of Animals Abroad (Australia) Limited 'SPANAN' Charity ABN 53617228109 for its general purposes and the receipt of a proper officer of this charity shall be sufficient discharge."

If you wish to donate a specific sum:

"I give the sum of A\$ (amount written in words and in numbers) to The Society for the Protection of Animals Abroad (Australia) Limited 'SPANAN' Charity ABN 53617228109 for its general purposes and the receipt of a proper officer of this charity shall be sufficient discharge."

If you wish to donate a specific item:

"I give to The Society for the Protection of Animals Abroad (Australia) Limited 'SPANAN' Charity ABN 53617228109 for its general purposes, my _____ and the receipt of a proper officer of this charity shall be sufficient discharge."

When writing or amending your Will, we recommend that you seek legal advice from a solicitor.
